Students have an opportunity to read internationally recognized author, Ruby Payne's book, A Framework for Understanding Poverty, in EDFN 442 Meeting the Diverse Needs of Students and Their Families. This is a required course for all teacher candidates. Also, all education majors are required to take Human Relations, EDFN 475. Current plans to revise curricular offerings include the increase of special education coursework for the general classroom teacher. Assessment instruments evaluate the ability for teacher candidates to instruct students with disabilities, from low-income families, and with limited English proficiencies. Finally, teacher candidates are provided with field experiences in both rural and urban schools.
