    - i. **Insight Level 1**- A class that may be required for all students on their first violation of the alcohol and other drug policy. The online module consists of alcohol and drug prevention education and provides an opportunity for the student to learn about alcohol or drug use.
    - ii. **Insight Level 2**- NSU utilizes the curriculum "Prime for Life", and the class is held monthly depending upon the number of referrals to the program. This Saturday class runs from 8:00 am – 5:00 pm with a break for lunch.
    - iii. **Insight Level 3**- NSU utilizes the curriculum "Interactive Journaling" and is administered through 6 individual sessions with a certified trainer. Students are generally assigned to this class after a
