This three-credit course prepares candidates to integrate evolving technologies into the curriculum and their instruction. Candidates learn many theoretical frameworks that focus on teaching with technology. They are required to complete several lesson plans and to teach two lessons with a focus on the integration of technology. Candidates also take EDER 415 Educational Assessment. This two-credit course prepares candidates to use technology to collect, manage, and analyze data to improve teaching and learning. The unit hosted a CAEP site visit in the spring of 2021 and was granted accreditation with one stipulation in the spring of 2022. The stipulation review occurred in the spring of 2023 and the cAEP team is recommending the removal of the stipulation. A final decision will come from the Accreditation Council in late October.
