#### **Course Description**

This course provides an overview of the field of clinical mental health counseling. Students explore historic, philosophical, and sociocultural trends in mental health counseling. Additionally, they will explore health service delivery modalities, legislation, government policy, legal, and regulatory processes. This course prepares students for further study and professional practice by integrating theoretical foundations with practical applications. 3 credits

The proposed course offers a distinct overview of clinical mental health counseling, emphasizing foundational aspects of the field, including historical, philosophical, and sociocultural trends, as well as legal and regulatory processes. It integrates theoretical concepts with practical applications relevant to professional practice.

In contrast, COUN-713 focuses on the management of human services programs within community counseling settings, while CHRD-713 emphasizes the development and administration of counseling programs in agency environments. Whereas the proposed course provides a broad foundational understanding that includes elements of program development, the other two courses concentrate specifically on administrative and management practices.
