NURS 239 Course Description

An introduction to the nursing profession. Includes content related to the history of nursing, the nursing process, therapeutic communication, cultural and spiritual awareness, legal and ethical issues in nursing, critical thinking, care of the geriatric patient, and the role of the registered nurse in practice. Introduces basic nursing skills such as comfort measures, activities of daily living, aseptic and sterile environments, oxygen therapy, wound care, non-parenteral medication administration and other selected skills. Co-requisites: NURS 239L, NURS 238, and NURS 269L

NURS 239L Course Description

Provide practical experience in the application of NURS 239 content where students will demonstrate competency in application of the nursing process. Co-requisite: NURS 239

NURS 204 is for LPN-BSN students, whereas our course is for traditional BSN students. Additionally, NURS 204 is a 1-credit course, whereas ours is a 3-credit course with a lab component.

NURS 272 is a professional concept course and does not include a skill component, whereas our course includes a skill component. Additionally, NURS 272 is a 2-credit course, whereas ours is a 3-credit course with a lab component.

The NSU course includes introductory professional concepts in addition to basic skills and has a lab component. Nursing curricula and course breakdown vary between all programs as they are tailored to each school's unique characteristics and goals, just as Northern's program is being tailored to our unique characteristics and goals.
