Evidence-based practice, technology, professional standards and inter-professional collaboration are used to develop clinical reasoning skills that enhance patient-centered, safe and effective care. Co-requisite: NURS 329L, NURS 328 and NURS 355 Pre-requisites: NURS 238, NURS 239/L, NURS 269/L and NURS 327

### NURS 329L Course Description

Evidence-based practice, technology, professional standards and inter-professional collaboration are used to develop clinical reasoning skills that enhance patient-centered, safe and effective care. Co-requisite: NURS 329
