Reinforces the nursing role related to interventions that promote health, prevent disease, and restore health. Focuses on the delivery of care to women and childbearing families, the pediatric population, and selected adult clients with acute and chronic health conditions. Evidence-based practice, technology, professional standards, and inter-professional collaboration are used to develop clinical reasoning skills that enhance patient-centered, safe, and effective care with individuals and populations across the lifespan. Co-requisites: NURS 333, NURS 369, NURS 378, NURS 379L. Pre-requisite: NURS 238, NURS 239/L, NURS 329/L, and NURS 355.

# **NURS 379L Course Description**

Evidence-based practice, technology, professional standards, and inter-professional collaboration develop clinical reasoning skills that enhance patient-centered, safe, and effective care with individuals and populations across the lifespan. Co-requisite: NURS 379

Nursing curricula and course breakdown vary between all programs as they are tailored to each school's unique characteristics and goals, just as Northern's program is being tailored to our unique characteristics and goals.
