Course Description

This course explores the theory, structure, and administration of Work-Based Learning (WBL) in Career and Technical Education (CTE) programs. Students will investigate the philosophy, development, implementation, coordination, and evaluation of Cooperative Career and Technical Education (C-CTE) and other WBL models, with a focus on aligning programs with federal, state, and local policy frameworks. Emphasis will be placed on the roles/responsibilities of teacher-coordinators, legal and safety compliance, employer engagement, program improvement, and equitable access.

3.3. Proposed instructional method by university (as defined by <u>AAC Guideline 2.4.3.A</u>): Please provide a brief description of how the course is appropriate for the instructional method, as defined in AAC Guidelines.

The proposed instructional method for this course is Lecture (R). CTE 450/550 is well-suited to the lecture format because the content is rooted in theory, principles, and established practices that form the foundation of Work-Based Learning (WBL) in Career and Technical Education. Topics such as program structure, federal and state policy frameworks, teacher-coordinator responsibilities, and legal and safety compliance require a highly structured environment in which the instructor formally presents factual and regulatory information.

The lecture format ensures straightforward communication of complex and technical material that students may have little prior knowledge of, such as CTE models, program evaluation methods, and compliance requirements. Providing this information through formal lectures allows students to develop a solid knowledge base before applying concepts in practical settings. The format also accommodates varying enrollment sizes, making it suitable for both undergraduate and graduate students enrolled in the dual-level course.
