This course will be offered at NSU as part of the Environmental Science major. This is a basic introduction to students planning graduate study or employment in natural resources management. This course will be offered at NSU and focus on the theory and techniques of wildlife management and conservation in the US.

While a similar course is offered at SDSU, our course is focused on the ecological perspective as well as the wildlife management perspective, which means we are combining two foci into one course, much like BIOL 377. Again, it goes back to faculty and course loads and how we can best provide the courses/content knowledge to students. Further, we don't have authority to offer courses with a prefix outside of biology, so we are requesting to offer this course within the biology prefix.
