ELED 766 provides a broader view of teaching and learning processes and is at a higher graduate level that will not accommodate the accelerated MSEd in Instructional Design in E-Learning. ELRN 435/535 will focus on instructional design in online learning environments, as well as facilitate the revised, accelerated MSEd in Instructional Design in E-Learning.

Also similar is LT 716, Systematic Design of Instruction. The course description for this course states, "This course provides concepts and tools for applying systems theory to instructional design, including needs, instructional, learner, and context analyses, objectives, assessment, strategy, development, and evaluation. Addresses client-learning needs in various organizational settings: business, industry, government, health care, education, and not-for-profit. The current course, ELRN 435/545 differs from LT 716 primarily in context as it is directly related to designing content and teaching students in an online format. LT 716 covers other areas in addition to education such as business and industry and those areas would not apply to designing curriculum for and teaching k-12 students. Finally, the current course is designed for students in both undergraduate and graduate programs. LT 716 is a higher-level graduate course and would not be available for undergraduate students.
