In addition, the Foundation is subject to income tax on net income that is derived from business activities that are unrelated to its exempt purpose. The Foundation files an Exempt Organization Business Income Tax Return (Form 990T) with the IRS to report its unrelated business taxable income due to the rental of the President's home to the University and revenue earned on alternative investments held by the Foundation, which has resulted income tax expense of \$4,517 and \$212,365 for the years ended June 30, 2017 and 2016, respectively, which is reported as a reduction of net investment return on the consolidated statement of activities. As a single-member limited liability company, FOHO I, LLC is treated as a "disregarded entity" for income tax purposes. Therefore, FOHO I, LLC's financial activity is reported in conjunction with the Federal income tax filings of the Foundation.

The Foundation believes that it has appropriate support for any tax positions taken affecting its annual filing requirements, and as such, does not have any uncertain tax positions that are material to the consolidated financial statements. The Foundation would recognize future accrued interest and penalties related to unrecognized tax benefits and liabilities in income tax expense if such interest and penalties are incurred.
