Provide explanation of differences between proposed course and existing system catalog courses below:

The course proposed differs from the existing courses as it addresses early childhood development as a whole versus only the appropriate assessment practices as noted in the existing course. The course description for ECE 408 states, "This course explores valid, reliable, and developmentally appropriate assessment practices utilized to identify young children (ages birth through five) with special needs and emphasizes the importance of promoting family engagement and collaboration with other professionals to positively support children's development and learning."

The proposed course will address student development, instructional methods and services for ages birth to age 8. This aligns with the South Dakota early childhood special education endorsement, allowing endorsement completers to teacher birth to age 8. The course description listed for ECE 408 only addresses students to age 5.

The proposed course differs from SPED 771 as it is available to students in undergraduate programs as well as those enrolled in master's level programs. The course description for SPED

771 reads, "Study of assessments and interventions employed with young children with special needs" and is only offered for students at an advanced degree level."
